Notice is hereby given to the shareholders/unitholders of the subfunds of the Companies and of the FCPs (the "Subfunds"), that in the context of the restructuring of Credit Suisse Group AG, the Companies/Management Company have decided to align the Subfunds as follows, it being understood that the prospectuses of the Companies and of the FCPs will be amended accordingly as soon as practicable.

1. Securities Lending

The Companies/Management Company may now enter into securities lending transactions with affiliates of Credit Suisse Group AG other than Credit Suisse AG (i.e. Credit Suisse (Schweiz) AG).

2. Share/Unit Class Hedging

The foreign exchange transactions in relation to Share/Unit Class Hedging may be executed now by affiliates of Credit Suisse Group AG other than Credit Suisse AG (i.e. Credit Suisse (Schweiz) AG).

3. Change of ownership of Management Company

Whereas the sole shareholder of the Management Company has changed from Credit Suisse Holding Europe (Luxembourg) S.A. to Credit Suisse Asset Management International Holding AG back in December 2016, the new and final shareholder of the Management Company as a result of the restructuring measures taken within Credit Suisse Group AG will be Credit Suisse Asset Management & Investor Services (Schweiz) Holding AG which is ultimately owned by Credit Suisse Group AG, with effect as of 24 March 2017.

4. Change of Investment Manager

The Companies/Management Company have decided to change the investment manager of the subfunds listed in the appendix from Credit Suisse AG to Credit Suisse Asset Management (Schweiz) AG, as of 24 March, 2017.

The fees charged to the investors are not affected by this and remain unchanged.

Furthermore, the management teams with regard to each of the subfunds concerned remain unchanged.

Shareholders/unitholders should note that, once updated the new prospectuses of the Companies and of the FCPs and the key investor information documents as well as the management regulations/articles of incorporation may be obtained in accordance with the provisions of the prospectuses at the registered offices of the Companies/Management Company or on the internet at www.credit-suisse.com.
