Notice is hereby given to the Shareholders of the subfund Credit Suisse (Lux) Fixed Maturity Bond Fund 2020 S-I (the “Subfund”)

Based on the provisions laid down in the prospectus, the Subfund will run until 30 September 2020 (the “Maturity Date”). The shareholders are hereby informed that the intention is to discontinue the Subfund at the Maturity Date.

The Board of Directors hereby confirms the final maturity of the Subfund on 30 September 2020.

Redemption applications have been accepted up to 3 p.m. CET on 25 September 2020.

The Final Redemption Proceeds will be determined on the basis of the net asset value calculated on 29 September 2020 based on the closing prices of 28 September 2020.
